County wide Eligibility.

Wayne County Four Star is available exclusively to Wayne County small businesses with 2 - 100 employees. The business must have over 50% of their employees residing here and have employees who have not participated in an employer sponsored health plan in the last 12 months. At least half of the employees of the group must earn less than \$16.00 per hour.

Or, if you have group coverage that has significantly risen in cost, you may also qualify. Coverage is available to employees, spouses, and qualifying children. **It's best to call to determine your company's eligibility.**

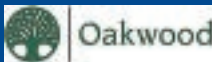
