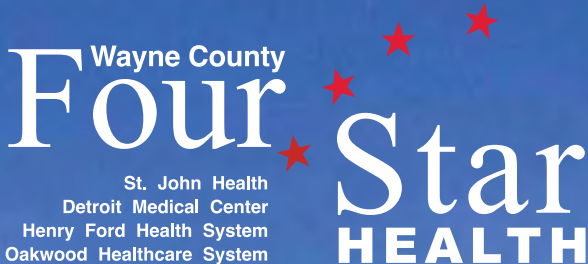
Coverage is available to employees, spouses, and qualifying children.
